

**Great Homeschool Conventions, Inc.**  
**TERMS AND CONDITIONS OF SERVICE**

This agreement is a binding, legal contract between you (the “Affiliate”) and Great Homeschool Conventions (GHC). As an Affiliate, you agree to the following terms:

1. **Promotional Materials.** GHC shall make available to Affiliate certain advertisements for display and use on Affiliate’s website and/or email lists. Affiliate shall display the Promotional Materials on Affiliate’s website and/or email lists prominently and as Affiliate sees fit. The manner of display shall be subject to this Agreement. Affiliate shall include a link from the Promotional Materials to GHC’s website.
2. **Use of Promotional Materials.** The Affiliate’s use of the Promotional Materials on the Affiliate’s site shall conform to the following terms: (a) Affiliate may only use graphics that are approved in writing by GHC prior to use; (b) Affiliate may only use the Promotional Materials for the purpose of promoting GHC; (c) The Promotional Materials may only be used to link to the Internet links specified by GHC; and (d) Affiliate will not alter or otherwise modify the Promotional Material.
3. **Commissions.** In exchange for Affiliate’s display of the Promotional Materials, and for Affiliate’s compliance with and performance of this Agreement, GHC shall pay a commission. The commission shall be based upon the percentage of sale in effect at the time of sale per product or subscription sold to a user that accesses GHC’s website through a link through a “bona fide click-through.” GHC reserves the right to change the price of its products and commission percentages without notice. Commissions are based on the percentage of sale in effect at the time. Commissions shall be paid through PayPal at a flat rate per sale.
  - a. A “bona fide click-through” is any successful attempt by a visitor of Affiliate’s website to click on the link within the Promotional Materials on Affiliate’s website to visit GHC’s website. GHC shall have sole discretion to determine whether any click-through(s) shall qualify as bona fide click-throughs. Affiliate shall not attempt to: (i) artificially generate click-throughs to GHC’s website by use of deception; (ii) incentivize or otherwise encourage Affiliate’s employees, customers, or other persons to click the link to GHC’s website for any purpose other than the promotions offered through the GHC’s website; or (iii) use of any mechanism that automatically generates click-throughs to GHC’s website. Affiliate may not receive or attempt to receive commissions on the Affiliate’s own purchases.
4. **Affiliate represents and warrants that Affiliate’s website does not contain any materials that are sexually explicit, pornographic, suggestive, offensive, hateful, defamatory, discriminatory, or graphically violent.**
5. **Term.** This Agreement shall take effect immediately upon sign-up and participation in this program and shall remain in effect indefinitely or until terminated. Either Party has the right to terminate. The terminating party must give written notice at least 30 days prior to termination.
6. **Governing Law.** This Agreement shall be construed with and governed by the laws of the State of Ohio.
7. **Severability.** If any part or parts of this Agreement shall be held unenforceable for any reason, the remainder of this Agreement shall continue in full force and effect.
8. **Entire Agreement.** This Agreement constitutes the entire agreement between GHC and Affiliate, and supersedes any prior understanding or representation of any kind preceding the date of this Agreement.
